



HUNGARY RESIDENCY BY INVESTMENT PROGRAMME

Hungary's new Residency by Investment programme, also known as the Guest Investor Visa, officially launched in July 2024. This programme is designed for foreign investors eager to invest in Hungary's real estate market, offering a range of exclusive benefits. Participants gain the right to live, work, and study in Hungary, allowing them to immerse themselves in the nation's rich culture and diverse industries. Furthermore, successful applicants enjoy visa-free travel within Europe's Schengen Area, enabling seamless movement across multiple countries. Investors can also include their spouses, children, and even parents in their application. Applicants can choose to invest €250,000 into a government approved property investment fund or directly invest €500,000 into residential real estate. (Real estate route not open until January 2025)

Investment Options

- €250,000 Approved property investment fund; or
- €500,000 Residential real estate investment; or
- €1,000,000 Donation to designated public trust.
